

**YELLOWHEAD COUNTY  
BYLAW NO. 4.04**

*BEING A BYLAW TO ESTABLISH  
THE NUMBER OF COUNCILLORS TO BE ELECTED  
TO SERVE ON YELLOWHEAD COUNTY COUNCIL  
AND TO PROVIDE FOR THE ELECTION OF THE  
CHIEF ELECTED OFFICIAL BY THE ELECTORS OF THE COUNTY*

**WHEREAS**, the Council for Yellowhead County wishes to adjust the electoral boundaries of Yellowhead County Council and ensure that the population distribution amongst the wards is consistent (see Schedule "A" attached);

**AND WHEREAS**, the Council for Yellowhead County wishes to change the electoral structure of Council from ten (10) wards and an appointed Chief Elected Official to eight (8) wards and an elected Chief Elected Official;

**AND WHEREAS**, the Council for Yellowhead County wishes to enact this bylaw to be in effect for the October, 2004 municipal general election;

**AND WHEREAS**, Sections 148 and 150 of the Municipal Government Act, Being Chapter M-26, R.S.A., 2000, provides that a Council may by bylaw change the wards and provide for a chief elected official elected by the electors of the municipality;

**NOW THEREFORE**, the Council for Yellowhead County, in the Province of Alberta, duly assembled, hereby enacts as follows:

1. For the purposes of the October 2004 general municipal election and thereafter, Yellowhead County Council shall be comprised of a Chief Elected Official and eight (8) councillors with one (1) councillor elected from each ward.
2. The number and boundaries of each of the eight (8) wards shall be as illustrated on the map titled as Schedule "B" and as identified by legal description in Schedule "C", which are attached to and form part of this bylaw and shall exclude any and all incorporated municipalities and Indian Reserves situated therein.
3. The Chief Elected Official of Yellowhead County shall be elected by a vote of the electors of Yellowhead County.
4. The Chief Elected Official for Yellowhead County shall be called the "Reeve".

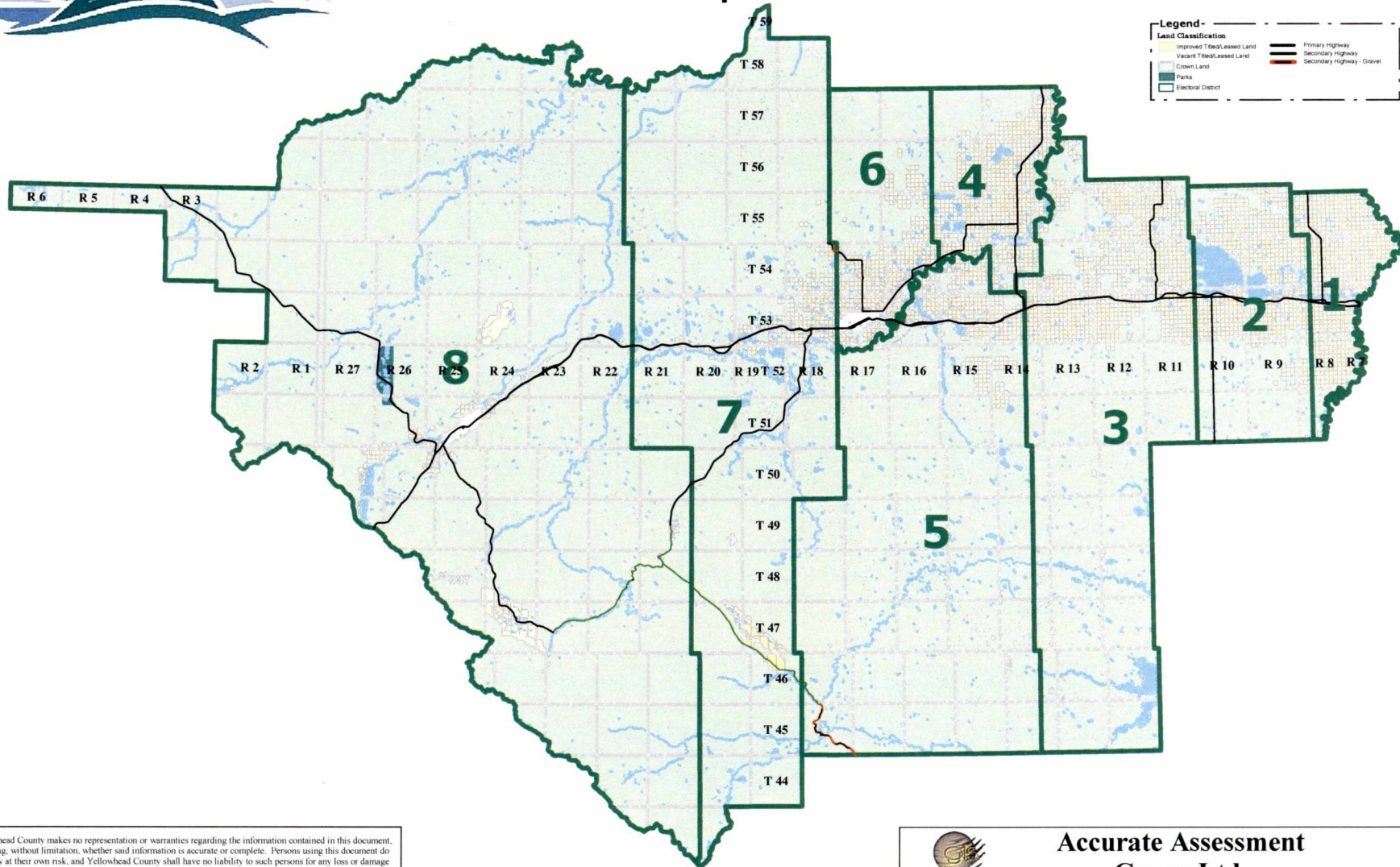

## **Schedule "C"**

### **WARDS IDENTIFIED BY LEGAL DESCRIPTION**

All lands described herein being situated and lying in the province of Alberta, west of the fifth (5<sup>th</sup>) Meridian unless noted in the description.

#### **Ward One**

Township 55. All those portions of ranges 7 and 8 lying generally west of the Pembina River, excepting thereout sections 31 to 36 inclusive of range 8, and sections 31 to 33 inclusive of range 7;

Townships 54 to 52. Sections 1 to 4, E ½ 5, E ½ 8, 9 to 12, 13 to 16, E ½ 17, E ½ 20, 21 to 24, 25 to 28, E ½ 29, E ½ 32, 33 to 36 in range 8 and all those portions of ranges 6 and 7 lying west of the Pembina River;

Township 51. All those portions of range 8 lying west of the Pembina River in range 8 up to and including the east halves of Sections 5, 8, 17, 20, 29, and 32.

#### **Ward Two**

Township 55. All of ranges 9 and 10;

Township 54 to 51. Sections 6, 7, 18, 19, 30, and 31 and the west halves of Sections 5, 8, 17, 20, 29, and 32 in Range 8, and all of ranges 9 and 10.

#### **Ward Three**

Township 56. Sections 1 to 6 inclusive in ranges 11 and 12 and all those portions of range 13 lying generally east of the McLeod River;

Township 55. All those portions of ranges 11 to 13 inclusive lying generally east of the McLeod River;

Township 54. All of ranges 11 to 13 and Sections 1, 2, 3, 10, 11, 12, in range 14;

Township 53. All of ranges 11 to 13 and Sections 1, 2, 11, 12, 13, 14, 23, 24, 25, 26, 35 and 36 in range 14;

Townships 52 and 51. All of ranges 11 to 13 and Sections 1, 2, 11, 12, 13, 14, 23, 24, 25, 26, 35 and 36 in range 14;

Townships 50 to 45. All of ranges 12 and 13 and Sections 1, 2, 11, 12, 13, 14, 23, 24, 25, 26, 35 and 36 in range 14.

**Ward Four**

Townships 57 and 56. All those portions of range 13 lying generally west of the McLeod River and all of ranges 14 and 15 inclusive;

Township 55. All those portions of range 13 lying generally west of the McLeod River and all of ranges 14 and 15 inclusive;

Township 54. All of Sections 4 to 9 and 13 to 36 in range 14 and all those portions of range 15 lying generally north of the McLeod River.

**Ward Five**

Township 54. All of ranges 15 and 16 lying generally south and east of the McLeod River;

Township 53. Sections 3 to 10, 15 to 22, and 27 to 34 in range 14, all those portions of range 15 and all those portions of ranges 16 and 17 lying generally south east of the McLeod River;

Township 52. Section 3 to 10, 15 to 22, and 27 to 34 in range 14, all those portions of range 15 and 16, and all that portion of range 17 lying generally south east of the McLeod River;

Townships 51 and 50. Sections 3 to 10, 15 to 22, and 27 to 34 in range 14 and all those portions of ranges 15 to 17 inclusive;

Townships 49 to 45. Sections 3 to 10, 15 to 22, and 27 to 34 in range 14 and all those portions of ranges 15 to 18 inclusive.

**Ward Six**

Townships 57 to 55. All of ranges 16 and 17;

Township 54. All those portions of range 16 lying generally north west of the McLeod River and all of range 17;

Township 53. All those portions of ranges 16 and 17 lying generally north west of the McLeod River;

Township 52. All those portions of range 17 lying generally north of the McLeod River.

**Ward Seven**

Township 59. All of range 19 lying generally south of the Athabasca River;

Township 58. All of range 18, that portion of range 19 south east of the Athabasca River and those portions of ranges 20 and 21 south of the Berland River;

Township 57. All of ranges 18 to 20 inclusive, that portion of range 21 lying generally south east of the Berland River;

Township 56 to 51 All of ranges 18 to 21 inclusive;

Township 50. All of ranges 18 to 20 inclusive;

Township 49 to 44. All of ranges 19 to 20 inclusive;

Township 43. All those portions of range 20 lying generally north of the Jasper National Park boundary;

Township 42. That portion of range 20 lying generally north of the Jasper National Park Boundary.

### **Ward Eight**

Township 58. All of those portions of ranges 22 to 26 inclusive lying generally south of the Berland River;

Township 57. All those portions of ranges 22 to 27 inclusive lying generally south of the Berland river, all those portions of range 1, township 57, west of the sixth (6<sup>th</sup>) meridian lying generally south and east of the Berland River;

Township 56. All of ranges 22 to 27 inclusive, that portion of range 1, township 56, west of the sixth (6<sup>th</sup>) meridian lying generally east of the Berland River;

Township 55. All of ranges 22 to 27 inclusive, ranges 1 to 3 inclusive and sections 19 to 36 inclusive of ranges 4 to 6 inclusive of township 55, west of the sixth (6<sup>th</sup>) meridian;

Township 54. All of ranges 22 to 28 inclusive, all of ranges 1 to 3 inclusive west of the sixth (6<sup>th</sup>) meridian, excepting thereout sections 1 to 6 inclusive, range 3, township 54, west of the sixth (6<sup>th</sup>) meridian;

Township 53. All of ranges 22 to 28 inclusive, all of range 1, west of the sixth (6<sup>th</sup>) meridian;

Township 52. All of ranges 22 to 28 inclusive, all of ranges 1 and 2 west of the sixth (6<sup>th</sup>) meridian;

Township 51. All of ranges 22 to 28 inclusive, those portions of ranges 1 and 2 lying generally north and west of the Jasper National Park boundary, west of the sixth (6<sup>th</sup>) meridian;

Township 50. All those portions of ranges 21 to 28 inclusive lying generally north of the Jasper National Park Boundary, that portion of range 1 and 2 lying generally north of the Jasper National Park boundary, township 50, west of the sixth (6<sup>th</sup>) meridian;

Township 49. All those portions of ranges 21 to 27 lying generally north and west of the Jasper National Park Boundary;

Township 48. All those portions of ranges 21 to 26 inclusive lying generally north and west of the Jasper National Park Boundary;

Townships 47 and 46. All those portions of ranges 21 to 25 inclusive lying generally north and west of the Jasper National Park Boundary;

Township 45. All those portions of ranges 21 to 24 inclusive lying generally north of the Jasper National Park Boundary;

Township 44. All those portions of ranges 21 and 23 inclusive lying generally north of the Jasper National Park Boundary;

Township 43. All those portions of ranges 21 and 22 lying generally north of the Jasper National Park Boundary.

5. This bylaw repeals Bylaw No. 1.04.


