

BYLAW NO 05.11

BEING A BYLAW OF YELLOWHEAD COUNTY, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF IMPOSING A LOCAL IMPROVEMENT TAX IN RESPECT OF LANDS THAT DIRECTLY BENEFIT FROM THE HAMLET OF PEERS WATER DISTRIBUTION SYSTEM LOCAL IMPROVEMENT PROJECT.

WHEREAS, the Council for Yellowhead County has decided to issue a bylaw pursuant to Section 397 of the *Municipal Government Act* to authorize a local improvement tax levy to pay for the Hamlet of Peers Water Distribution System local improvement project;

AND WHEREAS, a local improvement plan has been prepared and the required notice of the project given to the benefiting owners in accordance with the attached Schedule A and Schedule B and no sufficient objection to the Hamlet of Peers Water Distribution System local improvement project has been filed with the County's Chief Administrative Officer;

AND WHEREAS, the Council has decided to set a uniform tax rate based on the number of parcels assessed against the benefiting owners;

AND WHEREAS, Plans and specifications have been prepared, the project has been completed and the total cost of the project is \$1,996,008 and the following contributions will be applied to the project:

Yellowhead County at Large	\$998,004
Benefiting Owners	\$998,004
Total Cost	\$1,996,008

The local improvement tax will be collected for TWENTY FIVE (25) years and the total amount levied annually against the benefiting owners is SEVENTY ONE THOUSAND EIGHT HUNDRED SEVENTY NINE DOLLARS AND EIGHTY EIGHT CENTS (\$71,879.88);

AND WHEREAS, all required approvals for the project have been obtained and the project is in compliance with all *Acts* and *Regulations* of the Province of Alberta;

AND WHEREAS, it has been determined that any newly subdivided lot shall bear the costs of the construction of the connection from the local improvement to the streetline and said construction is approved by Council;

NOW, THEREFORE, the Council of Yellowhead County, duly assembled, enacts as follows:

- That for the purpose of completing the Hamlet of Peers Water Distribution System local improvement project the sum of NINE HUNDRED NINETY EIGHT THOUSAND, FOUR DOLLARS (\$998,004) be collected by way of an annual, uniform local improvement tax rate assessed against the benefiting owners as provided in Schedule A and Schedule B attached.
- 2. The net amount levied under the by-law shall be applied only to the local improvement project specified by this bylaw.
