



BYLAW NO. 26.15

*A BYLAW OF YELLOWHEAD COUNTY
FOR THE PURPOSE OF CLOSING TO PUBLIC TRAVEL AND SELLING A PORTION OF 1ST STREET (PLAN
6484KS) AND ALL OF PLAN 152-0694 IN ACCORDANCE WITH SECTION 22 OF THE MUNICIPAL
GOVERNMENT ACT, BEING CHAPTER M-26, R.S.A., 2000, AS AMMENDED.*

WHEREAS, Section 22 of the Municipal Government Act, Being Chapter M-26, R.S.A., 2000, as amended authorizes a municipality to close a road under its direction, control and management by bylaw, and

WHEREAS, the lands hereafter described are no longer required for public travel, and

WHEREAS, application has been made to Council to have the street closed, and

WHEREAS, the Council of Yellowhead County deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads, or portions thereof, situated in the said municipality, and

WHEREAS, notice of the intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act, Being Chapter M-26, R.S.A., 2000, and

WHEREAS a public hearing was held pursuant to the Municipal Government Act, Being Chapter M-26, R.S.A., 2000;

NOW THEREFORE, the Council for Yellowhead County, in the Province of Alberta, duly assembled, hereby enacts as follows:

- 1) That the lands shown in the attached Schedule "A" and described as follows:

*PLAN 6484KS
ALL THAT PORTION OF 1ST STREET LYING SOUTH OF THE PRODUCTION SOUTHWESTERLY
OF THE SOUTHEASTERLY CURVILINEAR BOUNDARY OF HIGHWAY STREET AS SHOWN ON
PLAN 1421842
CONTAINING 0.592HECTARES (1.46 ACRES) MORE OR LESS
EXCEPTING THEREOUT ALL MINES AND MINERALS*

AND

*PLAN 152-0694
ALL OF ROAD PLAN 152-0694
CONTAINING 0.074 HECTARES (0.183 ACRES) MORE OR LESS
EXCEPTING THEREOUT ALL MINES AND MINERALS*

be hereby closed to public travel.








