

BEING A BYLAW TO AUTHORIZE APPOINTMENTS UNDER THE AGRICULTURAL SERVICE BOARD ACT, THE WEED CONTROL ACT, THE AGRICULTURAL PESTS ACT AND THE SOIL CONSERVATION ACT

WHEREAS, the Municipal Government Act, R.S.A., 2000 authorizes a Council to pass bylaws to delegate any of its powers, duties or functions to a council committee, the chief administrative officer or a designated officer

AND WHEREAS the Agricultural Service Board Act requires a municipality to appoint a qualified person as the agricultural fieldman to implement agricultural policies and programs and to manage the agricultural resources of the municipality

AND WHEREAS the Weed Control Act requires that the local authority of a municipality shall appoint a sufficient number of inspectors to carry out the Act within the municipality

AND WHEREAS the Agricultural Pests Act requires the local authority of a municipality shall appoint a sufficient number of inspectors to carry out duties under the Act and Regulations within the municipality

AND WHEREAS THE Soil Conservation Act requires the local authority of a rural municipality to appoint at least one soil conservation officer to meet the needs of the municipality under the Act

NOW THEREFORE, the Council of Yellowhead County in the Province of Alberta, duly assembled, and pursuant to the authority conferred upon it by the Municipal Government Act, R.S.A., 2000, c. M-26, with amendments thereto, enacts as follows:

- 1. The Chief Administrative Officer of Yellowhead County shall be delegated the authority to appoint an agricultural fieldman as required under the Agricultural Service Board Act.
- 2. The Chief Administrative Officer of Yellowhead County shall be delegated the authority to appoint inspectors or officers as required under the Weed Control Act, the Agricultural Pests Act and the Soil Conservation Act and to rescind those appointments as may be required from time to time.
- 3. The agricultural fieldman and any inspectors or officers appointed under this bylaw shall be provided with identification supplied by Yellowhead County in a form prescribed by the regulations of the above Acts and shall show it on request.
- 4. The agricultural fieldman and inspectors or officers will be required to return their identification to Yellowhead County upon termination of employment which will rescind the appointment.
- 5. The adoption of this bylaw comes into force upon the date of passing the third and final reading of this bylaw.
