

#### **Cemetery Special Projects Grant**

Yellowhead County has grant funding available to community groups who are operating a cemetery in the County and require funding for special projects in a cemetery. Registered non-profit groups will be eligible to apply for funding up to a maximum of \$2,500 for a Cemetery Special Projects Grant to assist with the non-operational costs for cemetery improvements. Applicants are encouraged to call the County with any questions regarding this grant application process.

#### **Grant Criteria:**

- 1. Eligible costs include but are not limited to such items as surveys, ground radar imaging, fencing, maintenance equipment and concrete leaders for headstones.
- 2. There must be a clearly defined financial need for Cemetery Special Project support.
- 3. A financial statement of the previous year must accompany the application.
- 4. The applicant must demonstrate self-help in the Special Project by providing a minimum of 50% of the costs of project either through contribution of monies or volunteer labour, materials or equipment. Labour will be calculated at \$15 per hour and donated major equipment with an operator at \$60 per hour.
- 5. Maximum funding from Yellowhead County cannot exceed 50% of the total cost of the Special Project. Yellowhead County's contribution will not exceed \$2500.
- 6. Annual maintenance will not be considered under this grant category.
- 7. County Council will consider all grant applications and will budget funding in the upcoming year for those projects approved.


