## **RENTAL CONDITIONS**

1. THE OWNER SHALL SUPPLY EQUIPMENT IN GOOD WORKING CONDITION.
2. THE OWNER SHALL PROVIDE WORKERS' COMPENSATION BOARD COVERAGE FOR ALL OPERATORS OF THE EQUIPMENT INCLUDING PERSONAL COVERAGE FOR DIRECTORS AND COVERAGE FOR EMPLOYEES THAT OPERATE THE EQUIPMENT.
3. RATES INCLUDE OPERATOR'S WAGES, WORKERS' COMPENSATION COVERAGE, FUEL, OIL, REPAIRS, SERVICING, AND OTHER COSTS ASSOCIATED WITH OWNING AND OPERATING EQUIPMENT.
4. MOBILIZATION, DEMOBILIZATION, AND ANY MOVING COSTS FROM ONE YELLOWHEAD COUNTY PROJECT TO ANOTHER WILL BE PAID BY THE COUNTY, IF APPLICABLE. THE OWNER IS RESPONSIBLE FOR ALL COSTS ASSOCIATED WITH REPAIRING OF THE EQUIPMENT INCLUDING ANY MOVING COSTS INCURRED FROM THE WORK SITE TO THE REPAIR FACILITIES CHOSEN BY THE OWNER.
5. THE OWNER TO PROVIDE SKILLED, WELL-TRAINED OPERATORS.
6. THE OWNER IS RESPONSIBLE FOR PROVIDING THE EQUIPMENT NOTED ON THE REVERSE SIDE AND SHALL MAINTAIN IT IN GOOD CONDITION DURING THIS AGREEMENT. THE OWNER IS RESPONSIBLE FOR PROVIDING THE INSURANCE AGAINST LOSS OR DAMAGE TO THE EQUIPMENT.
7. YELLOWHEAD COUNTY, IN THE ABSENCE OF ITS NEGLIGENCE, IS NOT RESPONSIBLE FOR ANY LOSS OR DAMAGE TO THE EQUIPMENT.
8. EQUIPMENT SHALL MEET ALL SAFETY REGULATIONS UNDER THE OCCUPATIONAL HEALTH AND SAFETY ACT.
9. THE OWNER MUST CARRY COMPREHENSIVE GENERAL LIABILITY INSURANCE AGAINST BODILY INJURY AND PROPERTY DAMAGE CLAIMS. COVERAGE MUST INCLUDE LIABILITIES ASSUMED UNDER WRITTEN CONTRACT. THE OWNER AGREES TO PROVIDE UPDATED POLICY INFORMATION IF ANY CHANGES OCCUR.
10. THE OWNER AGREES TO INDEMNIFY AND HOLD HARMLESS YELLOWHEAD COUNTY, ITS EMPLOYEES AND AGENTS FROM ANY AND ALL CLAIMS AND DEMANDS ARISING OUT OF OWNERS PERFORMANCE OF THIS AGREEMENT.
11. PROCESSING OF PAYMENT WILL COMMENCE UPON RECEIPT OF INVOICE.
12. IF THE OWNER DOES NOT ADHERE TO THE ABOVE CONDITIONS, YELLOWHEAD COUNTY SHALL HAVE THE RIGHT TO TERMINATE THIS AGREEMENT AT ANY TIME, WITHOUT PENALTY.
13. THIS IS TO CERTIFY THAT THE PROPERTY AND/OR SERVICES ORDERED OR PURCHASED BY YELLOWHEAD COUNTY ARE SUBJECT TO THE GOODS AND SERVICES TAX.
