

# Participant Agreement

Release of Liability, Assumption of Risk, Indemnity & Media Consent

This agreement is required to participate in: Go Girl 2026 and related activities (the "Program").

## Assumption of Risk

## Waiver, Release & Indemnity

In consideration of being allowed to participate, I/we agree:

- To waive any and all claims now or in the future against the Community Development Department of the Municipality of Jasper and the Municipality of Jasper.
- To release them from all liability for any injury, illness, death, loss, or damage, including those caused by negligence.
- To indemnify and hold them harmless from any claims, damages, legal fees, or costs arising from participation.
- That this agreement is binding on myself and my heirs, next of kin, executors, administrators, and assigns.

## Media Consent

I give the Municipality of Jasper permission to take and use photos, video, or audio recordings of me/my child for promotional and communication purposes, including print, online, social media, and advertising. I understand that I will not be paid, waive any right to approve their use, and release MOJ from any claims related to their use.

## Emergency Medical Consent
