

### HISTORICAL PROGRAMS & FACILITIES GRANT APPLICATION

#### INFORMATION PACKAGE

Yellowhead County has grant funding available to community groups in the County who are operating a historical facility and/or providing a historical program to the general public. Eligible facility based projects must be located in Yellowhead County.

This grant may be used for general operational expenses such as utilities, staff and general maintenance and upgrading. It may also be used for capital improvements such as new building construction, grounds improvements, parking upgrades and acquisitions. Applicants can only apply for 50% of the funding required for any capital project.

Eligible applicants will have non-profit societal status and must provide a copy of their last annual financial statement.

Applicants that can show support from the community in the form of dollars, donated equipment and supplies, volunteer labor and/or support in principal will be given priority.
